FEES: REGISTRATION TUITION PRODUCTION MEMBERSHIP	<p>FEES STATEMENTS ARE SENT VIA EMAIL AND ALL FEES ARE NON-REFUNDABLE. REGISTRATION is paid once a season and is due with Summer Intensive or at time of enrollment.</p> <p>TUITION may be paid in one or two payments, or monthly, and may be pro-rated for those who join during the season. Monthly payments are due on the 1st of the month, past due on the 5th, and subject to a \$25 late fee. The monthly payment for June will be charged as a ½ month. ALL TUITION charged MUST be paid in order to participate in the production.</p> <p>PRODUCTION FEES for Nutcracker and Spring Performances include costuming and production fees. Participation requires payment of all tuition to cover the extensive rehearsals the week prior to the performance which easily exceeds normal class time allotment. Please note: performers will receive costumes only after all fees and payments have been satisfied.</p> <p>MEMBERSHIP FEES apply to be eligible to participate in Productions including (Nutcracker) and Special Events and must be paid to participate in Nutcracker Bootcamp.</p>
